

AMENDMENT NO. 2 TO CONSULTANT SERVICES AGREEMENT

This Amendment No. 2 ("Second Amendment") to the August 1, 2018, Consultant Services Agreement ("Agreement") executed by the City of Monrovia, a California municipal corporation ("City") and Mountainside Communion - A Church of the Nazarene, a California, non-profit corporation ("Consultant"), is dated August 4, 2020 ("Effective Date"), and is between City and Consultant.

RECITALS

A. City and Consultant executed the Agreement to provide for Consultant to develop a Housing Displacement Response Program.

B. City and Consultant desire to amend the Agreement to modify: (1) the term; and (2) the compensation amount.

The parties therefore agree as follows:

1. Amendment to Section 2 – Term of Agreement

Section 2 of the Agreement is hereby amended to read as follows:

"This Agreement shall be from the Effective Date until June 30, 2022, unless terminated earlier as provided in Section 13 of this Agreement."

2. Amendment to Section 3 – Compensation

Section 3(A) of the Agreement is hereby amended to read as follows:

"A. Compensation. As full compensation for Consultant's services provided under this Agreement, City shall pay Consultant an amount to total \$90,000.00 for the duration of this contract [as shown below](#):

[1. Prevention and Diversion Funding = \\$15,000](#)

[a. Funds must be used by December 31, 2021](#)

[b. Implementation fees = \\$1,500 \(Compensation to Mountainside Staff / Client Manager\)](#)

[c. Support Families Impacted by COVID = \\$13,500 \(To Program Participants through Mountainside\)"](#)

[2. Implementation of Funding = \\$75,000](#)

[a. Funds must be used by June 30, 2022](#)

[b. Implementation fees = \\$15,000 \(Compensation to Mountainside Staff / Client Manager\)](#)

[c. Support Families Impacted by COVID = \\$60,000 \(To Program Participants through Mountainside\)](#)

3. Preservation of Agreement

Except as expressly modified or supplemented by this Second Amendment, all of the provisions of the Agreement shall remain unaltered and in full force and effect.
