

**MINUTES OF THE SPECIAL AND REGULAR MEETINGS OF THE
MONROVIA CITY COUNCIL
HELD TUESDAY, SEPTEMBER 5, 2023, 7:30 P.M.**

STUDY SESSION: Mayor Becky A. Shevlin convened the Special Study Session of the Monrovia City Council on Tuesday, September 5, 2023, at 5:04 p.m., to discuss the State of the City's Finances: Past, Present, and Future. All members were present, with the exception of Councilmember Crudginton who was excused. In attendance were City Manager Dylan Feik and City Attorney Craig A. Steele. Mayor Shevlin adjourned the study session at 5:50 p.m.

SPECIAL MEETING: Mayor Shevlin convened the Special Meeting of the Monrovia City Council on Tuesday, September 5, 2023, at 6:01 p.m., for a workshop to review New California Campaign Contribution Regulations presented by Craig A. Steele, City Attorney. Mayor Becky Shevlin adjourned the special meeting at 6:53 p.m.

CONVENE: Mayor Shevlin convened the Regular Meeting of the Monrovia City Council on Tuesday, September 5, 2023, at 7:30 p.m. in honor of Caridad "Lola" Papa's 110th birthday. In attendance were City Manager Dylan Feik, City Attorney Craig A. Steele, and Assistant to the City Clerk Sarah Godinez.

INVOCATION: Police Chaplain Terrence Brown led the invocation.

PLEDGE OF ALLEGIANCE: Councilmember Sergio Jiménez led the pledge of allegiance.

The City Council received a request from Councilmember Gloria Crudginton to participate remotely due to an emergency. **It was moved by Mayor Shevlin, seconded by Councilmember Jimenez, to approve Councilmember Crudginton's participation remotely pursuant to Government Code Section 54953(f).** The motion carried unanimously by roll call vote.

ROLL CALL: In attendance were Councilmembers Gloria Crudginton, Sergio P. Jiménez, Dr. Tamala Kelly, Mayor Pro Tem Larry J. Spicer, and Mayor Becky A. Shevlin. Councilmember Crudginton participated remotely pursuant to Government Code Section 54953(f).

REPORT OF CLOSED SESSION: City Attorney Craig A. Steele reported that the City Council met in Closed Session on August 1, 2023, at which all members were present to discuss the two items on the posted agenda. There was no reportable action.

PR-1 Proclaiming the Month of September 2023 as "National Suicide Prevention Month": The Mayor and City Council presented a proclamation to Ulises Gutierrez, Executive Director, iNSPIRE.

PR-2 Proclaiming September 10-26, 2023, as "National Patriotism Week": Mayor Shevlin called on Fire Chief Jeremy Sanchez and Police Chief Alan San Victores, and recognized and thanked all Monrovia first responders.

ORDER OF BUSINESS: Consent Calendar items CC-3, CC-6, and CC-7 were pulled from the Consent Calendar for discussion.

CONSENT CALENDAR: It was moved by Councilmember Dr. Kelly, seconded by Councilmember Crudginton, to approve the consent calendar, with the exception of items CC-3, CC-6, and CC-7. The motion carried unanimously by roll call vote. The consent calendar consisted of the following items:

CC-4 Ratification of Emergency Purchase and Installation of Two (2) Tait Radio Repeaters From Foothill Communications, Inc., in the Amount of \$45,779.77; and Approve a Contingency Amount not to Exceed \$6,800.00: The City Council ratified the emergency purchase and installation of two Tait radio repeaters from Foothill Communications, Inc., in the amount of \$45,779.77, approved a contingency in an amount not to exceed \$6,800, and appropriated an amount not to exceed \$52,579.77 from the Capital Projects Fund.

CC-5 Revision to the Art Installation for Alexan Foothills Residential Development at Station Square West: The City Council approved the mural design depicted in Option 1 and authorized the City Manager to execute the required documents in a form approved by the City Attorney.

CC-6 Consultant Services Agreement with The Converse Professional Group dba Converse Consultants for a Geotechnical Investigation along the 400 Block of Cloverleaf Drive in an Amount Not to Exceed \$35,940; and Approve a Contingency in an Amount Not to Exceed \$3,594.00: This item was pulled from the Consent Calendar for discussion.

The motion carried unanimously by roll call vote.

It was moved by Mayor Pro Tem Spicer, seconded by Councilmember Jimenez, to find that there was a need for immediate action which could not reasonably wait for the next regularly scheduled Meeting, and that the need for such action came to the attention of Staff after the Agenda was posted for the following two items. The motion carried unanimously by roll call vote.

Following discussion, the City Council unanimously supported the Committee's Resolution opposing House of Representatives Bill HR3372 regarding the use of heavy vehicles on our streets, and were 4-1 in favor of the Committee's Resolution supporting State Senate Bill 233 regarding electric vehicle and electric vehicle supply equipment, with the caveat that school districts not be required to replace buses prematurely.
