

**MINUTES OF THE SPECIAL AND REGULAR MEETINGS OF THE  
MONROVIA CITY COUNCIL  
HELD TUESDAY, MARCH 19, 2019, 7:30 P.M.**

**STUDY SESSION:** Mayor Tom Adams convened the Study Session of the Monrovia City Council on Tuesday, March 19, 2019, at 6:07 p.m. City Council Chambers, 415 S. Ivy Avenue, Monrovia, California, at which all members of the City Council were present, to discuss the Sign Ordinance. Mayor Adams adjourned the Study Session meeting at 6:47 p.m.


