

**MINUTES OF THE SPECIAL AND REGULAR MEETINGS OF THE  
MONROVIA CITY COUNCIL  
HELD TUESDAY, MARCH 7, 2017, 7:30 P.M.**

**STUDY SESSION:** Mayor Pro Tem Alexander C. Blackburn convened the Special Study Session Meeting of the Monrovia City Council at 6:00 p.m. on Tuesday, March 7, 2017, in City Council Chambers, 415 South Ivy Avenue, Monrovia, California, at which all Councilmembers were present, with the exception of Mayor Tom Adams, who was excused. City Manager Oliver Chi, Police Chief Jim Hunt, and City Attorney Craig Steele, provided an overview of Proposition 64 and possible next steps related to local marijuana regulations. Following discussion, staff was directed to schedule another study session for further review with examples of low-level, mid-level, and strict regulatory schemes. Mayor Pro Tem Blackburn adjourned the meeting at 7:01 p.m.
