

**MINUTES OF THE SPECIAL AND REGULAR MEETINGS OF THE  
MONROVIA CITY COUNCIL  
HELD TUESDAY, JULY 5, 2022, 7:30 P.M.**

**CLOSED SESSION:** Mayor Tom Adams convened the Special Meeting / Closed Session of the Monrovia City Council on Tuesday, July 5, 2022, at 6:00 p.m., to discuss: CS-1 Conference with Legal Counsel, Existing Litigation Pursuant to Government Code §54956.9(d)(1); City of Long Beach, et al. v. Monsanto Company, et al., United States District Court, Central District of California – Western Division, Case No. 2:16-cv-03493-FMO-AS. All members were present. Mayor Adams adjourned the closed session at 6:25 p.m.


