HELD TUESDAY, FEBRUARY 7, 2017, 7:30 P.M.**

CLOSED SESSION: Mayor Tom Adams convened the Closed Session Meeting of the Monrovia City Council at 5:00 p.m. on Tuesday, February 7, 2017, in City Council Chambers, 415 South Ivy Avenue, Monrovia, California, at which all Councilmembers were present, to discuss the following Closed Session items: CS-1 Conference with Labor Negotiator pursuant to Government Code §54957.6; Agency Negotiator: City Manager Oliver Chi; Group Employees: All Groups; CS-2 Conference with Legal Counsel, Initiation of Litigation Pursuant to Government Code §54956.9(d)(4); Two (2) Potential Cases. Mayor Adams Adjourned the meeting at 7:30 p.m.

CONVENE: Mayor Tom Adams convened the Regular Meeting of the Monrovia City Council of Tuesday, February 7, 2017, at 7:38 p.m. in City Council Chambers, 415 South Ivy Avenue, Monrovia, California. In attendance were City Manager Oliver Chi, City Attorney Craig A. Steele, and City Clerk Alice D. Atkins.

INVOCATION: Police Chaplain Terrence Brown led the invocation.

PLEDGE OF ALLEGIANCE: Councilmember Gloria Crudginton led the Pledge of Allegiance.

ROLL CALL: In attendance were Councilmembers Gloria Crudginton, Becky A. Shevlin, Larry J. Spicer, Mayor Pro Tem Alexander C. Blackburn, and Mayor Tom Adams.

REPORT OF CLOSED SESSION: City Attorney Steele reported that the City Council met in a joint closed session to discuss the two items on the posted agenda. There was no reportable action.

PR-1 Recognition of Fire Engineer Ernesto Moreno, Recipient of the Martin Luther King "Lifetime of Service" Drum Major Award: Fire Chief Brad Dover assisted the Mayor and City Council in recognizing Fire Engineer Moreno for his lifetime of dedication to volunteer efforts for the betterment of the community.

PR-2 Recognition of Ruhyyih Yuille and Lisa Labrie for the "Dreams for Our Children" Program at Monrovia Public Library: Recreation Manager Katie Distelrath assisted the Mayor and City Council in recognizing Ms. Yuille and Ms. Labrie for their leadership and dedication.

PR-3 Proclaiming February 2017 as "Black History Month": The Mayor and City Council presented a proclamation to Joannie and James Yuille who accepted on behalf of the Monrovia Duarte Black Alumni Association in honor of Black History Month.

CC-6 Consultant Services Agreement with Rancho Cucamonga Enterprise GIS (REGIS) Connect for On-Call Professional Services Associated with the City's Geographic Information System (GIS) for the Period Ending June 30, 2018:

CM Chi reviewed the report and provided greater detail regarding how GIS is used.

It was moved by Councilmember Spicer, seconded by Councilmember Shevlin, to approve an agreement with Rancho Cucamonga Enterprise GIS (REGIS) Connect for professional on-call GIS services for the period ending June 30, 2018, and authorize the City Manager or his designee to execute the necessary documents in a form approved by the City Attorney. The motion carried unanimously.
